## Science! Or science-y...

 Pyramid Lake Whitening - To those limnologist among our group, Pyramid Lake has been going through what's called a 'Whiting' event when a spontaneous precipitation of calcium carbonate, which occurs once every 7 to 12 years on our lake here in northern Nevada. I attached a satellite phot and some photos when it first started. You can read more on this unusual

This article says Whiting events can be triggered by microbiological processes, or resuspension of marine or bottom sediments. Planktonic blooms have known to associated with this event. We just went through a nodularia (cyanobacteria) bloom, which most likely triggered this event in Pyramid Lake. <a href="https://en.wikipedia.org/wiki/Whiting\_event">https://en.wikipedia.org/wiki/Whiting\_event</a>
